It was proposed by Cllr Mrs Myers, seconded by Cllr Luck and agreed unanimously the accounts for the year to 31 March 2012 be approved.

The Acting Clerk reported she had approached Pauline Bowdery, Clerk to Boxley Parish Council, about continuing to act as internal auditor. Mrs Bowdery had agreed to this but had said that this time she would charge. Her fee was likely to be in the range of $\pounds 40$ to $\pounds 60$. This was agreed.

It was proposed by Cllr Mrs Skudder, seconded by Cllr Mrs Myers and agreed the Audit Governance Statement for the year to 31 March 2012 be approved and signed by the Chairman and Acting Clerk.

It was proposed by Cllr Luck, seconded by Cllr Myers and agreed the Chairman's allowance be $\pounds 400$ for the year.

PUBLIC SESSION

The Chairman suspended the meeting for the public session.

The matter of speeding at the entrance to the Holiday Park was raised. Cllr Mrs Skudder said that if the school made a request, a project was available whereby children could speak to offenders. This had to be done through the police and the school would have to write.

There was a complaint about parking on the bend by the shops and a discussion followed about creating a layby and moving the bus stop.

It was reported that shoplifting was being done by young people. Cllrs Skudder and Lambourne offered to speak again to the shopkeepers.

It was reported that AFC01 light was out.

There was discussion about replacing one of the bins at the front of the shops with a bigger bin and reinstalling the litter bin that had been at the back of the shops in its former position. The Chairman thanked the members of the public and re-convened the meeting.

As Cllr Mrs Forrest had arrived, he reverted to items 7a and 8f

16 STREET CLEANING

43 a General Matters

It was reported that Mrs Colyer was back at work and had been off for a shorter time than expected.

44 b Storage Facility at Village Hall

Cllr Skudder said the shed was now installed and thanked Kieran Bussey for his help.

17 YOUTH

45 a Allhallows Little Explorers

Cllr Mrs Forrest said numbers had improved.

46 **b** Youth Club

Cllr Mrs Skudder reported that a local qualified teacher had offered to provide enrichment classes, free of charge. Icon Theatre wished to run a 6 day workshop with about 15-20 young people of 12-19 years during the summer holidays.

18 HIGHWAYS & TRANSPORT

47 a Footpath Officer's Report

The Chairman suspended the meeting to allow Mr Smith to give his report.

Mr Smith said there were more paths than he had realised. He had walked most of them but still had to go over to Yantlet creek. Most were in good order. He had not been able to get in touch with the Public Right of Way Officer. Cllr Mrs Myers reported flytipping on Homewards Road. Mr Smith said that he had seen evidence of quad bikes or 4 wheel drive vehicles on land between the track to slough Fort and Homewards Road. Cllr Mrs Myers wondered if the farmer had been crop spraying.

The Chairman thanked Mr Smith and reconvened the meeting.

48 **b** Rosehip Drive

The Acting Clerk was trying to establish who the developer was.

49 c Verge Cutting

Cutting of the verges was raised. It was queried why farm roads had been done but not the main road. It was also noted that the road markings were fading out.

12 MANAGEMENT OF THE COUNCIL'S LAND AND PROPERTY

a Recreation Ground and Playpark

- 50 i. General Matters. Medway Council had written that under the terms of the lease, they should not have been cutting the ground and that the Parish Council would have to make alternative arrangements from 11th June. The Acting Clerk had explained about parish precepts and the budgeting process and had copied in the Medway councillors. Cllr Irvine had negotiated that Medway Council would continue for this year but that the Parish Council would have the responsibility from April 2013. The Acting Clerk was asked to obtain a copy of the lease.
- 51 ii. Play park repairs. Cllr Mrs Skudder referred to the safety report and recent vandalism on the slide. The Acting Clerk was asked to contact Colyn Property Services to repair the urgent items as a matter of Health & Safety. With regard to the Proludic equipment, Maria Cook had said she would contact Heather Marsh of Medway Council about this as when the inspection was done, it was still under warranty. The Acting Clerk was asked to find out what was happening.
- 52 iii. Trees. The Acting Clerk reported Laverock Tree Care had carried out the work agreed. She had then received a telephone call from the resident of Shelduck Close, who had thanked the Council but said her ground floor rooms were still dark and asked that the remaining hawthorn trees be removed also. Laverock Tree Care had quoted a further £200 to do this work, clearing the small trees and rest of the undergrowth. It was proposed by Cllr Skudder, seconded by Cllr Mrs Myers and agreed this be done.
- 53 iv. Fence, St David's Road access. The Acting Clerk said that Dowle Fencing had not contacted her to arrange a site visit. She asked if the work should wait until the play equipment repairs had been done, but was informed that the contractors would have to use the access gate at the other end of the ground and the fence should be put up as soon as possible. She would approach other people for quotations.

54 **b** Village Hall

Cllr Skudder reported that fund raising events were being planned and the AGM was held on 25th April. The Committee remained the same. A dangerous tree in the car park had had to be felled as a matter of urgency.

55 c All Saints Allotments

In Cllr Marsh's absence, there was no report.

56 **d Woodland, Avery Way**

It was reported that the path through the woodland needed strimming.

e Cross Park

- 57 i. General matters. Cllr Skudder said he had obtained a quotation from Medway Council of £184.27 to put up a direction sign in Avery Way. He would obtain other quotations and bring them to the next meeting.
- 58 ii. Representative's report. Cllr Skudder reported on the last meeting. The outstanding issues had been discussed. He proposed a vote of thanks to Mr and Mrs Huntley-Chipper for all the work they had put in on the project.
- 59 iii. Acting Clerk's meeting with Association members. The Acting Clerk's report had been circulated prior to the meeting. The Acting Clerk said she had been invited to look round the building and had said she would help with preparing a business plan; however on arrival other members of the Association's committee were present. As her report stated, they had changed their minds and no longer wished to pursue running the building and had said that it was for the Parish Council to do so. They wished to remain a fund raising body. It was made clear to them that any of their ideas would have to be agreed by the Parish Council before they could start fundraising and that should the Parish Council want them to apply for grants for projects, they would do so.
- 60 iv. Premises Licence. The Acting Clerk reported that she had the form to complete. However the fee related to the rateable value and she would have to contact the valuation office first. Cllr Mrs Skudder said she believed no fee would be payable for a community building, but the form did not state this and in any case business rates would apply. The Association had not yet provided any paperwork.

f The Brimp

- 61 i. General Matters. Cllr Skudder reported that the gate had been broken and emergency repairs had been carried out.
- 62 ii. Social Club. Cllr Mrs Skudder reported that the insurance expired on 5th June and would not be renewed.
- 63 iii. Football arena. A vote of thanks was proposed to Mr Apostel for managing the project.
- 64 iv. Renewal of licence to the Youth Club. Having declared personal and prejudicial interests, Cllrs Skudder and Mrs Skudder left the room. Cllr Lambourne took the chair.

A draft licence that had been circulated prior to the meeting was discussed. The Youth Club was asking for use for 5 days a week and the Clerk would be informed which days would be used. The intention was to provide more flexibility than under the current arrangement. It was proposed by Cllr Lambourne, seconded by Cllr Mrs Myers and agreed the draft licence be accepted. Cllr Mrs Forrest suggested that consideration be given to a full lease when the licence was next due for renewal.
