# 3 FINANCE COMMITTEE

#### 245 a Terms of Reference

It was proposed by Cllr Mrs Skudder, seconded by Cllr Marsh and agreed unanimously that the revised Terms of Reference be adopted.

# 4 PERSONNEL COMMITTEE

#### 246 a Terms of Reference

It was proposed by Cllr Marsh, seconded by Cllr Mrs Skudder and carried by 6 votes for and 1 against that the Terms of Reference be adopted. Cllr Mrs Forrest asked that it be recorded that she disagreed with the section on delegated powers.

# 247 b Delegation to the Committee of all Matters Relating to the Clerk

Cllr Marsh, the Committee Chairman, asked the Acting Clerk to repeat information from the Council's solicitor regarding grievance and disciplinary hearings. Only one person could hold the hearing and the decision following the hearing was that person's alone. This was to prevent any thought of intimidation and to leave others available to hear any appeal without pre-judgement. The decisions made following hearings would be reported back to the Parish Council. Cllr Marsh said the Committee was asking for delegation to deal with the current issues to enable selection of people to take hearings and any following appeals and to progress matters. Cllr Mrs Martin proposed that

delegation be given to the Personnel Committee to deal with all matters relating to the Clerk. This was seconded by Cllr Mrs Myers and carried by 6 votes for and 1 against.

# 5 CONFIRMATION OF RESOLUTION

Cllr Mrs Martin proposed that the resolution to suspend the Clerk on full pay pending investigation into allegations of gross misconduct and to instruct the Council's solicitors, passed by 5 votes for, 1 against and 1 abstention in the confidential section of the meeting of the Council held on 25 May 2011 be confirmed and minuted in full as the matter was now in the public domain.
